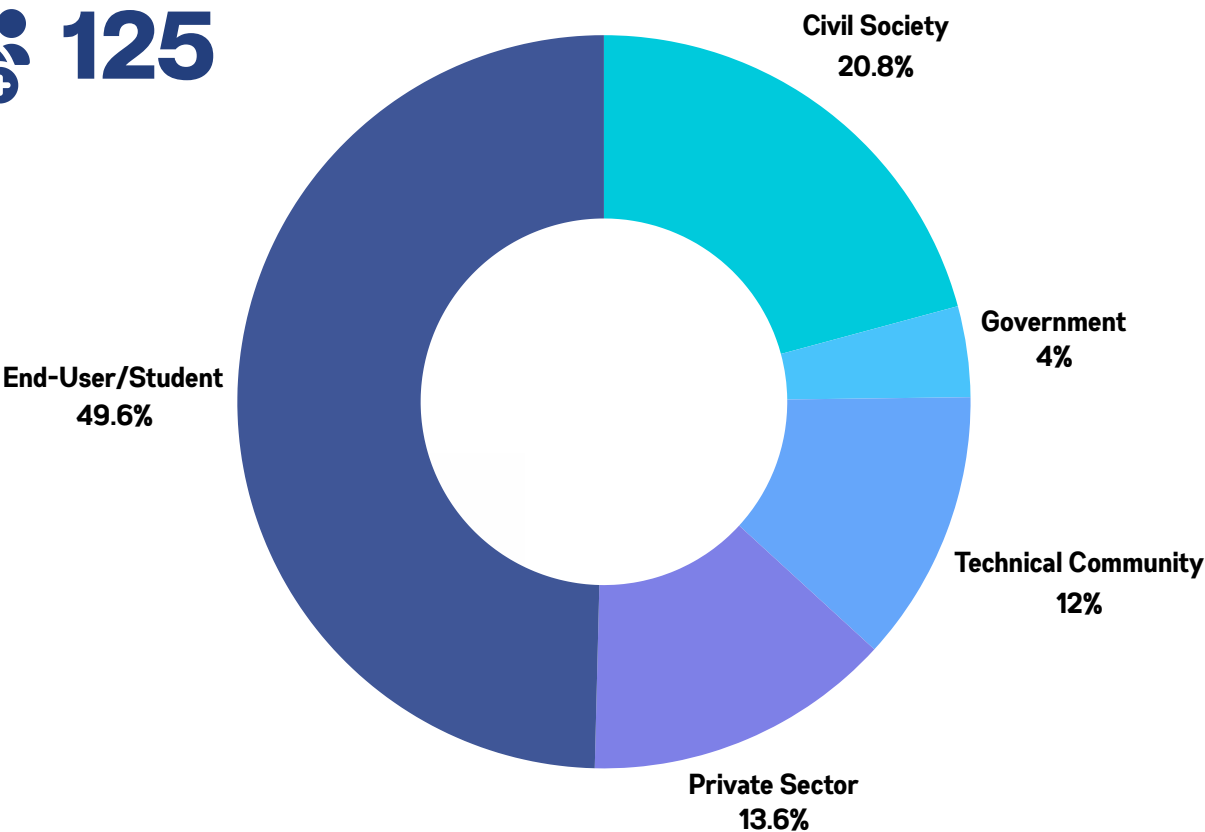

## INTRODUCTION

The Youth Internet Governance Forum (youth IGF) Nepal is a youth initiative that was formally recognised by the United Nations Internet Governance Forum Secretariat in December 2021. Its primary goal is to encourage and engage young people in substantive discussions about Internet governance.

youth IGF Nepal organises annual multi-stakeholder open forums to allow young people to exchange experiences, learn about Internet governance issues, and amplify their voices in national and international policy discussions.

This platform also helps to develop the capacity of youth from various stakeholder groups in emerging Internet governance issues such as the Digital Divide, Universal Access, AI Governance, Online Freedom of Expression, and others.

## YOUTH IGF 2024

The Youth IGF Nepal 2024 event was organised in Kathmandu, Nepal, at Hotel Himalaya on September 14. The event was scheduled in 14 sessions, from registration to the closing ceremony.

The Internet Society Nepal chapter hosted the event, while the National Youth Council was a policy partner and collaborator for this event. Key supporters included the Internet Society Foundation, Internet Governance Forum Support Association (IGFSA), Internet Society Youth Standing Group, and the Internet Corporation for Assigned Names and Numbers (ICANN).

Fellowships were supported by the Asia Pacific Network Information Center (APNIC), while Ai4Justice and the Internet Society Nepal Chapter hosted the reception. Additional community partners included Nepal Internet Exchange, Asian E-Learning, Imperial Law Associates, Tekkon Technologies, Insight Technology, Educating Nepal, Digital Rights Nepal, and Nepal Internet Foundation.

## OPENING PLENARY

In the first plenary discussion on Background about Internet Governance and Youth IGF Nepal, the stage was set by Hempal Shrestha. It was followed by the panel discussion, which was moderated by Mr. Ashirwad Tripathy. It included guests such as Mr. Surendra Basnet, Vice Chair, National Youth Council; Hon. Nim Giri, MP, Lumbini Provincial Assembly; Whip, Nepali Congress; Mr. Birendra Kumar Mishra, Nepal IGF Chair; Mr. Pradip Khatiwada, Founder Youth Innovation Lab; and Ms. Deepa Bhattarai, Immediate Past Chair, Youth IGF Nepal.

The session was filled with enriching discussion on the internet and its use. The participants posed pressing questions, which were answered by the panellists.

The first plenary discussion on Internet Governance and Youth IGF Nepal was initiated by Hempal Shrestha and moderated by Ashirwad Tripathy, featuring a panel of notable guests including Surendra Basnet, Vice Chair of the National Youth Council, and Nima Giri, MP of Lumbini Provincial Assembly. The session focused on the importance of youth participation in internet governance, with Basnet emphasizing its necessity in a rapidly changing technological landscape. Giri highlighted the need for youth to understand both digital tools and geography for effective governance.

Armita Choudhary, Chair of the Asia Pacific Regional IGF, and Anja Genjo from the UN IGF Secretariat also addressed the audience, underscoring the theme “Empowering Youths for an Open, Inclusive, and Secure Internet.” Choudhary pointed out the critical issues facing the internet today, such as security, privacy, and cybercrime, while advocating for multistakeholder collaboration in policy-making.

The panelists discussed various topics relevant to both Nepal and globally, including the digital divide and AI governance. They encouraged youth engagement in upcoming discussions at the IGF in Riyadh and emphasized the importance of including diverse voices in shaping internet policies. Overall, the session reinforced the vital role of youth in navigating and influencing internet governance.

## YOUTH AND MULTISTAKEHOLDERISM: OPPORTUNITIES FOR YOUTH IN THE INTERNET GOVERNANCE LANDSCAPE

The session was moderated by Mr. Samik Kharel, and the guests included Mr. Samiran Gupta (Vice President, Managing Director APAC, ICANN), Mr. Dibya Khatiwada (Community Trainer, APNIC) and Ms. Upasana Hembram (Associate Program Officer, ISOC Foundation).

The panel discussed the impact of internet governance and the growing development of artificial intelligence. According to Upasana, Internet governance is an uphill task.

Samiran Gupta highlighted that the multistakeholder model could be used to its full potential if young people came in and accelerated the process by merging knowledge and skills. He stated that multistakeholderism allows young people to be innovative and find better solutions.

Similarly, Upasana emphasised that youth bring a fresh perspective, which could aid in reaching consensus among the various stakeholders for a brighter future. What would a multistakeholder model look like? We do not know. But it for sure can bring some structure for better execution, added Samiran. However, to thrive, it is critical to understand how to use it more effectively and prepare for it.

Dibya Khatiwada, a community trainer, presenting his slides, said that it is crucial that everyone understands the technologies. He also said that it is very crucial that we have knowledge of segregating wrongs and rights on the internet, for which we need to devote our time to gain knowledge or participate in training like yIGF to enhance technological skills.

He also shared his experience and knowledge on global IP allocation. He also talked about IPv6 end users by region and in the context of Nepal. He also introduced the APNIC fellowship programs. He concluded with his remarks, saying everyone talks about policies, but it's very essential that we understand the technological side as we are dealing with it. “So as users of the internet, all of us should understand the technologies. We need not go into details; we just need to understand the basic things to be safe from hacking, malware, and phishing, he said.

## FLASH TALK: AI AND GOVERNANCE

Pranjal Timalisina, co-founder of Synapse Technologies, delivered a flash talk on AI and governance, discussing the dual nature of AI's impact on employment and efficiency. He emphasized that while some individuals effectively leverage AI to enhance productivity, others remain AI-illiterate and require significant support. Timalisina posed critical questions about trust in AI and humans, highlighting that past fatalities were primarily caused by human error rather than AI. He stressed the need for robust internet governance to keep pace with rapidly evolving technologies, such as ChatGPT. Timalisina advocated for ongoing dialogue through conferences and debates to bridge the gap between technological experts and policymakers. Participants raised concerns about AI's efficiency and sustainability, noting that while AI can be energy-intensive, countries like Nepal could benefit from their unique energy resources. He concluded by underscoring the importance of data security and compliance with agreements before using AI applications.

**ROLE PLAY: PLATFORM GOVERNANCE (BY ORGANIZING TEAM)**

The "Role Play: Platform Governance" session, led by the organizing team, engaged participants in a simulated discussion about governance issues related to the JHAMAJHAM app. Participants were divided into four groups: business, civil society, technical community, and government. Each group had ten minutes to discuss their assigned topics, focusing on aspects such as business ideas, social issues, technological challenges, and government agendas. During the presentations, the technical community highlighted data storage and multilingual support, while the government group raised privacy concerns regarding data deletion and the need for companies to register in Nepal for tax transparency. Civil society emphasized the importance of citizen safety and proposed solutions to combat misinformation. The session concluded with further discussions on content moderation and privacy policies, showcasing a collaborative effort to address key governance challenges in the digital landscape.

## FLASH TALK: MISINFORMATION AND DISINFORMATION

The discussion focused on misinformation and disinformation. It was presented by Rastra Bimochan Timals. He also described malinformation and helped the participants in distinguishing among the misinformation, disinformation, and malinformation. He briefed the participants on how to combat misinformation while maintaining free speech. He also emphasised the importance of being aware of legal codes governing technologies and information when dealing with them, such as the Electronic Transaction Act.

He also clarified the participants, referring to global trends like X (formerly Twitter) and Telegram. He emphasised the importance of enacting legislation to penalise those who spread misinformation.

## PROMOTING YOUTH'S ROLE IN ICT POLICY DISCOURSE ROUND TABLE WITH MPS AND POLICYMAKERS:

The session on the Internet Governance Landscape in Nepal featured presentations by: **Aananda Gautam, Babu Ram Aryal, and Lawmaker Hon. Pratima Gautam.**



They discussed the challenges and opportunities arising from increasing technology use. Gautam emphasized the importance of understanding the broader internet ecosystem and highlighted principles such as openness, security, and net neutrality. He also addressed key topics including access, privacy, freedom of expression, and the Social Media (Usage and Regulation) Bill. Aryal and Gautam pointed out that young people, despite being the largest internet users, are often excluded from policy development. They called for more inclusive multi-stakeholder discussions and emphasized the need for lawmakers to consult with youth and experts before passing legislation. The discussion underscored the importance of youth entrepreneurship in technology sectors and the necessity of addressing both opportunities and challenges presented by emerging technologies like AI. Lawmaker Gautam committed to organizing a roundtable with young people to ensure their voices are heard in future policy-making processes.





## DIGITAL LANDSCAPE OF NEPAL: CHALLENGES AND WAY FORWARD



The final session of the Youth IGF Nepal 2024, titled "Digital Landscape of Nepal: Challenges and Way Forward," was moderated by Usha Pandey, Head of Legal and Corporate Affairs at Daraz Nepal. The panel featured prominent speakers including MP Padam Giri, Dr. Dila Sangroula, Dipesh Bista, Tara Nath Dahal, and Nagesh Badu. Together, they explored the complexities of Nepal's digital landscape and emphasized that digitization encompasses much more than just the internet and social media.

The panelists collectively argued that the internet serves as a conduit for various sectors such as banking, agriculture, and education, with the overarching goal being the creation of a "Digital Nepal." However, they noted that the sector is expanding at an unsustainable rate, hindered by outdated laws and a lack of political prioritization. Padam Giri highlighted that while there are over 123 networks in Nepal, many legislative acts remain only drafted and not implemented. He pointed out that this stagnation is largely due to outdated mindsets among policymakers and ongoing political instability.

Dr. Dila Sangroula stressed that Nepal is falling behind in leveraging technology effectively. She called for increased focus on artificial intelligence and measures to combat corruption. Sangroula advocated for the integration of technology into various sectors, emphasizing the need for advancements in telemedicine and agriculture. She also highlighted the importance of open government practices and state transparency, particularly regarding budget information.

Nagesh Badu, an IT and e-governance specialist at the Ministry of Federal Affairs and General Administration, discussed his work on the Provincial and Local Governance Support Programme (PLGSP). He emphasized that e-governance is crucial for strengthening intergovernmental connections and improving service delivery across local bodies. Badu pointed out that while significant progress has been made in appointing IT officers to assist with digitalization efforts, challenges remain regarding infrastructure quality and sustainability.

The discussion also touched on critical issues such as poor internet connectivity and electricity supply. Badu argued that integrating services rather than having them scattered could significantly improve both speed and quality. He noted a lack of awareness at the policy level regarding digital issues, which hampers effective governance.

Dipesh Bista, Chief Executive Officer of the e-governance commission, shared insights about recent restructuring efforts within the commission. He explained that the commission aims to connect various government systems to improve overall service delivery. Bista highlighted a blueprint focused on ecosystem development rather than just application-based solutions. He referenced successful models from other countries, such as Estonia's X-road data exchange platform, which has significantly improved efficiency in public services.

Tara Nath Dahal discussed the historical context of internet development in Nepal and emphasized the importance of open government in maximizing technological benefits for citizens. He pointed out that while there is progress in digital identity initiatives, a comprehensive data exchange layer is still lacking.

The session concluded with an interactive Q&A segment where participants raised questions about various topics related to agriculture, IT, and digitalization. The panelists responded thoughtfully to these inquiries, reinforcing the need for inclusive policymaking processes that prioritize youth engagement.

Overall, this session underscored the critical challenges facing Nepal's digital landscape while also highlighting opportunities for growth through collaboration among stakeholders. The emphasis on open government practices, technological integration across sectors, and active youth participation in policymaking emerged as key themes for moving forward in Nepal's digital transformation journey.

## CLOSING CEREMONY

In the program's closing remarks, Ananda Gautam, chair of the youth IGF Nepal, stated that the Internet has become an inevitable part of our lives, and in this digital era where the Internet is the medium of all our activities, Internet governance and related subjects of lifelong learning. With the rapid development of information technology and the Internet, to ensure the access and participation of the youth in addressing the challenges and opportunities it creates and for the access and capacity development of the youth at the policy-making level of Internet governance, youth IGF Nepal will continue and call on all stakeholders to join the campaign to achieve this objective.
